April 12, 2012

Insurance Agent Report:

Bryan Steefland, new insurance agent for the region, was introduced. Bryan explained his background, plans for attending future meetings and some of the whole life insurance, annuity, disability and long term care products offered by the Knights of Columbus Insurance Company. He also reminded members of the accidental death benefit available to all members (\$1000 to \$2500 depending on age and years of service). Policy review (regardless of which company these are with) and coordination of collection on policies are additional services Bryan can provide. GK thanked Bryan for an excellent presentation.

Minutes:

Minutes of the March 1, 2012 meeting were read and approved as corrected.

Grand Knight Report:

GK Pyferron reminded members of upcoming election of officers for the 2012-2013 Council year. Several positions are currently vacant and members were asked to identify potential candidates. Nominees should be presented at the May meeting with election at the June meeting. Bob expressed his appreciation to Past GK Rea Schmid for his excellent service to the Council.

Delegates for the 2012 were presented for Council consideration. GK Pyferron and Mark Stadtherr were suggested for delegates with Mike Kleinschmidt and Tim Geisler suggested for alternates. Upon motion made and seconded, slate of delegates and alternates was approved. Bob will submit paperwork to the convention officials. The convention will be held in Rochester May 18 – 20th. Any member interested in attending any or all events or volunteering to help with the convention can contact him.

Financial Secretary Report:

Mark Stadtherr gave the FS report. Receipts during the month were \$480 for dues, \$4,143.50 in fish bake revenues and \$6 in miscellaneous revenues. He reported 2nd dues notices were sent out March 1st. Knight Alert letters have been prepared for GK signature giving members first notice of suspension if dues are not brought current. Of the 30 members in arrears, 7 have expressed interest in withdrawing. FS report was approved as presented.

Treasurer's Report:

Tim Geisler gave the Treasurer's report. Disbursements for March totaled \$1,723.40 and the checking account balance at the end of the month was \$5,976.70. Several fish bake expenses are yet to be paid and a final report should be available at the May meeting. Treasurer's report was approved as presented.

Fish Dinners:

Mike Kleinschmidt gave a preliminary report on the Lenten Fish Bakes. Revenues totaled approximately \$7,120 and expenses are about \$4,000. About \$850 will be contributed to the groups who helped with the dinners and about \$50 of food was donated to Dorothy Day House. The party for workers will be held April 16th @ 6:00. GK thanked Mike for his excellent leadership of this fundraising effort and all the workers who helped.

Ultrasound Project:

Mike Kleinschmidt reported he and Paul Lorentz had met with the donor and that negotiations on the purchase of the machine are still ongoing.

Donor Advised Fund:

Tim Geisler reported the Donor Advised Fund Committee had met in March and awarded two grants: \$15,000 to Lourdes Building Our Future and \$2,250 to Madonna Living Community.

KC Dance:

Bob Pyferron noted only 2 tickets had been purchased by council members for the KC Dinner Dance that will be held on April 13th.

Tootsie Roll Weekend:

Tim Geisler reminded members of the upcoming Tootsie Roll weekend on April 27, 28 & 29th. He passed around a sign up sheet for volunteers.

Road Clean Up:

Road clean-up is scheduled for May 5th. Volunteers should meet at Grandma's Kitchen at Silver Lake Shopping Center @ 8:00.

Donuts:

Volunteers are needed to work the May 6th Donut Sunday at St. Johns.

St. John's Block Party:

The St. John's Block Party will be back to a one day event to be held on July 14th. Volunteer signup kick-off event will be held on May 2nd.

Meeting Raffle:

The \$50 meeting raffle would have been won by **Brian Elsworth** had he been in attendance. Prize will go up to \$55 for the May meeting.

Meeting was adjourned @ 8:45 PM.
